Online Voting

- Voting happens **only online** between GA session
- Voting session lasts at least 48 hours
- Every LC that has paid membership fee are eligible to vote
 - Every LC has 1 voting right
 - No proxy votes or possibility to delegate your vote
 - Everyone has the ability to vote, don't have to be in person at IFSS
- Quorum is calculated for every voting session
 - 25% eligible LCs
 - 30% eligible LCs for changes in RoP/Statute


Voting system - Approve motions

- All motions in the GA are approved by a simple majority vote (vote in favours should be more than the vote against)
- In the ballot the options are
 - Approve
 - Reject
 - Abstain
- This is the default voting system. For example, used in:
 - Approve Agenda
 - Change in the RoP
 - Approve budget





IFSA Volunteers per region




Count of IFSA region

• MYTF

- Both parties will join forces to reach an even bigger audience, collaborate during relevant events that align with the parties' interests and create new events to involve their audience.
- IFSA and MYTF have worked together in projects like the IFSA Spring Course
- AFPA
 - Signed a 2-year MoU in December 2023 at UNFCCC COP 28 in Dubai




How the data was analysed?

- When you make calculations of forest properties, you don't measure every tree in the forest but just a representative sample (dataset)
- Data from the dataset is extrapolated to the whole population (forest)
- In this case, all IFSA is a forest and LCs are individual trees
- We "measured" 33.75 % of the "trees" and extrapolated it to the whole "forest"
- The result are approximations, not the exact hard data that's statistics











- Similar number of members and regional distribution BUT

- 3 times more in Northern America











