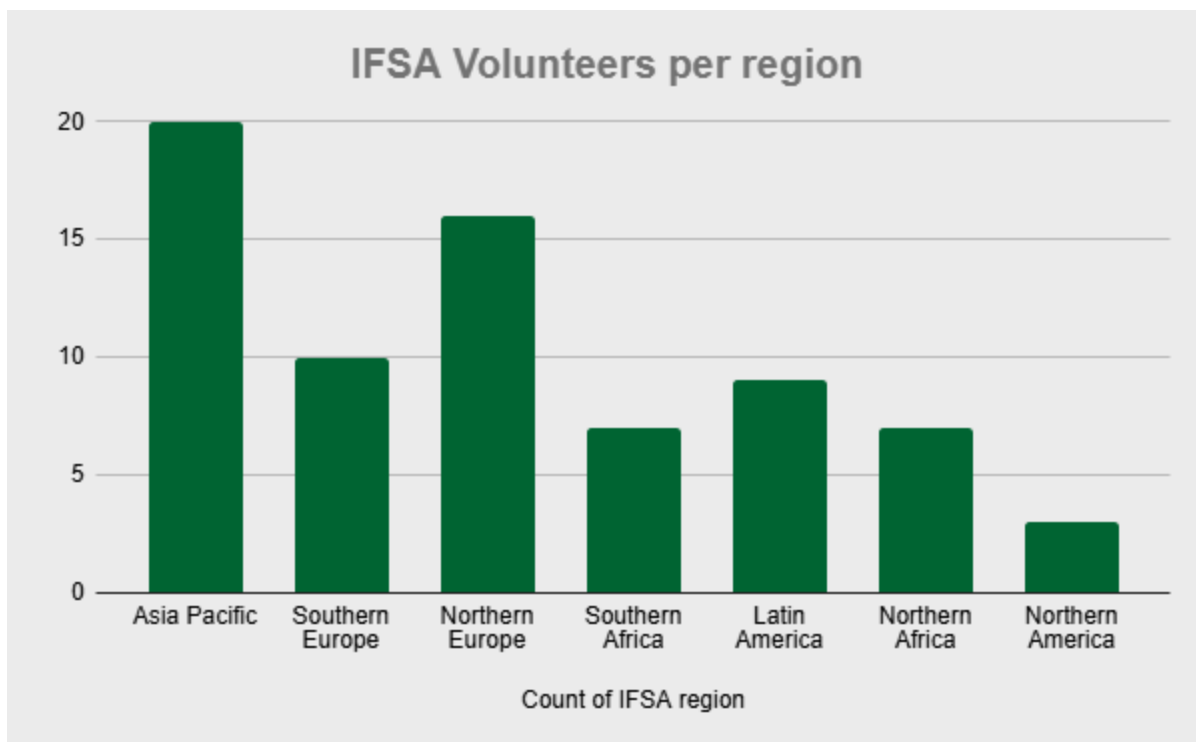

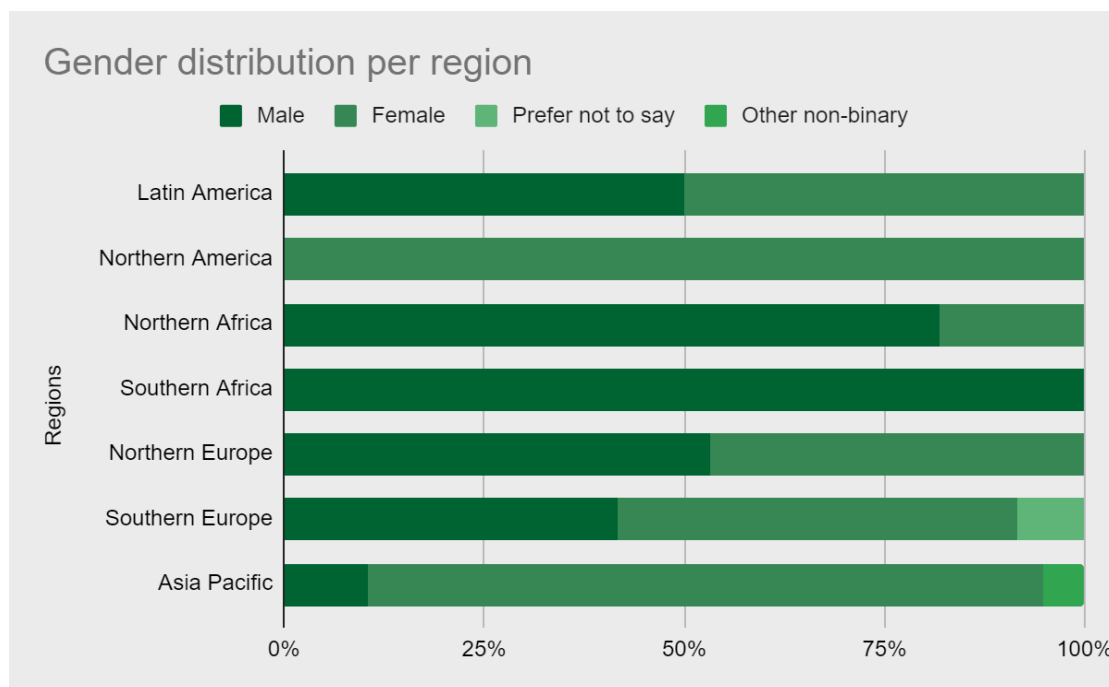
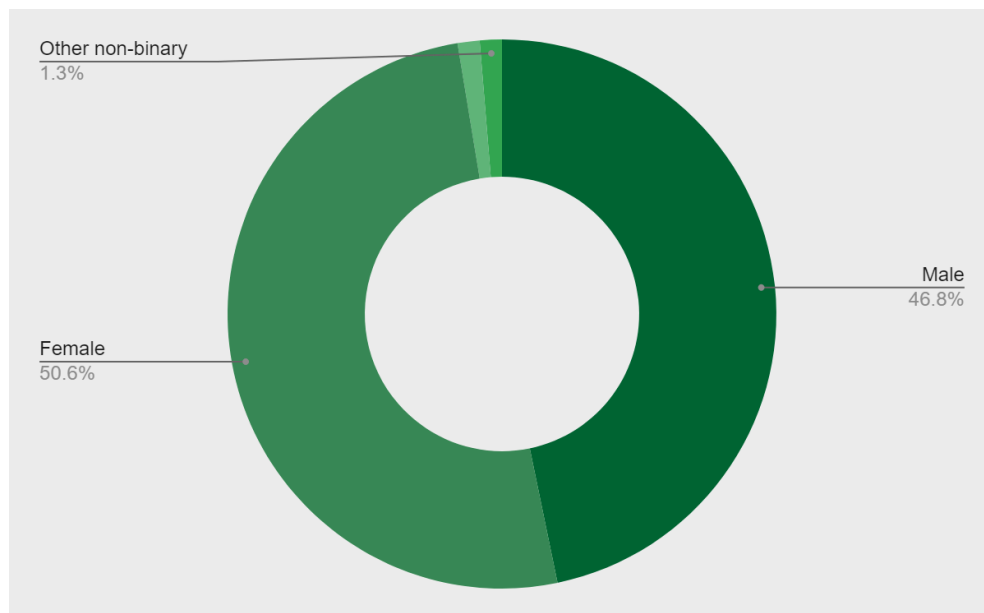

Task Forces

Code of Conduct

The International Forestry Students' Association (IFSA) focuses on inclusivity, equality, and community building in line with the IFSA Strategy 2022-2026. Our [Code of Conduct \(CoC\)](#) creates a respectful and safe environment by promoting openness, fairness, and cultural understanding, while maintaining zero tolerance for discrimination. Approved by all Local Committees (LCs) during the General Assembly, the CoC ensures professionalism and a discrimination-free space, with clear guidelines and an independent CoC Committee. Members are expected to use inclusive, gender-sensitive language and act respectfully in all interactions, including meetings and events. The CoC Committee, separate from the IFSA Board, handles reported cases confidentially, ensuring anonymity and fair resolution. Reports can be submitted anonymously, reviewed quickly, and addressed with actions ranging from warnings to suspensions or permanent exclusion. The CoC also emphasizes

the importance of data protection and avoiding conflicts of interest, reflecting IFSA's commitment to a professional, inclusive, and empowering student network.

Opportunities Task Force

With the aim of building an all-encompassing platform for career opportunities on the IFSA website, the IFSA Board created the Opportunities Task Force. This Task Force supported the development of internship proposals with IFSA partners, and designing the webpage. Composed of 9 IFSA members, the Task Force included 3 members from Asia Pacific; 2 from Northern Europe; 1 from Southern Europe; 1 member from Southern Africa; 1 from Northern Africa; and 1 from Latin America. IFSA-IAAS-IUAF Youth Task Force for the World Agroforestry Congress 2025

The Youth Task Force is a joint collaboration between IFSA, IUAF, and IFSA to support the youth engagement activities for the 6th World Agroforestry Congress in October 2024 in Rwanda. The Task Force members support proposal writing to strengthen youth participation in the event; and support tasks related to logistics, fundraising, communications, and/or program planning/management. Excluding the number of Task Force members from IAAS, there are a total of 6 IFSA members participating in the Youth Task Force, specifically 3 from Northern Africa, 3 from Asia Pacific, 1 from Southern Africa, and 1 from Northern Europe.

IFSA-School Forest Project

The Task Force for the IFSA-School Forest Project was established in December 2023, after the partnership agreement signed between School Forest Project and IFSA at the UNFCCC COP 28 in Dubai, United Arab Emirates. The Task Force collaborated on building the preliminary research; developing the TreE-Learning online course and quizzes; analyzing project results; and presenting its findings at the 26th IUFRO World Congress. With a total of 5 Task Force members, 3 members are from Northern Europe, 1 from Latin America, and 1 from Asia Pacific. 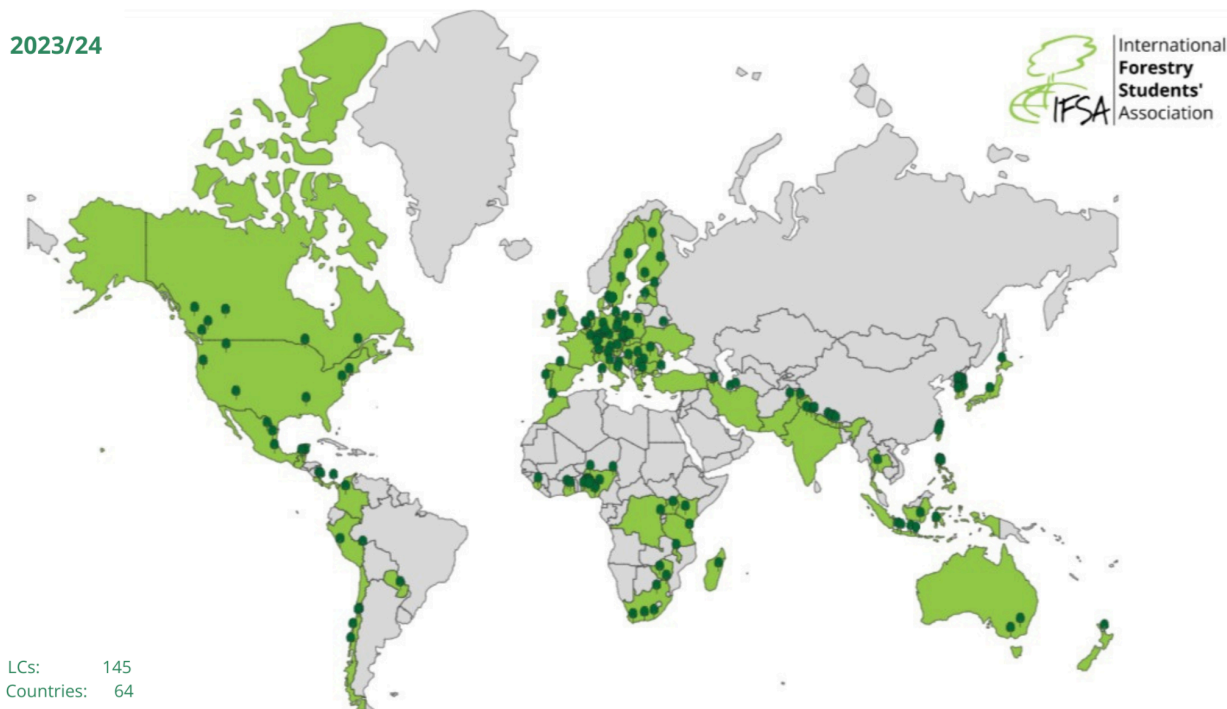

LC data collection

General description

Between July and September 2024, the Membership Department conducted its annual demographic survey among IFSA's Local Committees (LCs) for the third year in a row. Out of 145 LCs at the time, 57 responded—representing a response rate of 39.3%, compared to 81.5% in the first year and 67.1% in the second. To ensure continuity, missing data was extrapolated using information from previous years.

Results

The results showed a total of 14,138 members, reflecting a significant increase of approximately 21.5% from the previous year's 11,636 members. This growth is attributed not only to the establishment of new LCs, but also to updated data from previous years.

Based on the regional distribution of members, the highest share of members are located in the Northern African region (54.6%) with a total of 7,725 members, followed by Asia Pacific (12.1%) with 1,712 members, Northern Europe (9.1%) with 1,287 members, Southern Europe (9.0%) with 1,271 members, Southern Africa (8.8%) with 1,240 members, Latin America (3.6%) with 507 members, and Northern America (2.8%) with 396 members. This data has shown the same trend of distribution as the previous year.

Gender-wise, IFSA recorded 4,983 male members and 4,700 female members by 2022/2023. In 2023/2024, these numbers increased to 6,470 males and 6,115 females. The number of members identifying as non-binary remained consistent at 181 across both years, while the "Prefer not to say" category saw a slight increase, from 68 to 71 members.

The male-to-female ratio remained nearly unchanged, with no statistically significant difference—approximately 1.06 in both years. However, there was a slight decrease in the proportion of non-binary members (from 1.56% in 2022/2023 to 1.28% in 2023/2024), as well as in the "Prefer not to say" category (from 0.58% to 0.50%).

Based on their participation in Local Committee (LC) activities, members are categorised as either active or passive. Passive members are those who are officially part of an LC but participate in fewer than two activities (projects and meetings) per year. In the 2023/2024 term, there were 6,039 active members, representing 42.7% of the total. This marks a shift toward greater passivity, with 57.3% of members classified as passive (a 4.7% increase) compared to the previous term's 52.6%.

In terms of study level of IFSA members, the data showed a notable shift in the distribution of study levels between the 2022/2023 and 2023/2024 terms. In 2022/2023, the majority of members were enrolled in bachelor's programs, accounting for 84.7% of the total membership. Master's students comprised 13.3%, while PhD students represented only 2.0%.

In 2023/2024, although bachelor students continued to represent the largest share of members, their proportion declined to 75.9% (10,730 members), indicating a decrease of 8.8%. Similarly, the proportion of master's students dropped to 8.0% (a 5.3-point decline; 1,125 members), and the PhD category saw a slight reduction to 1.05% (down 0.95%; 149 members).

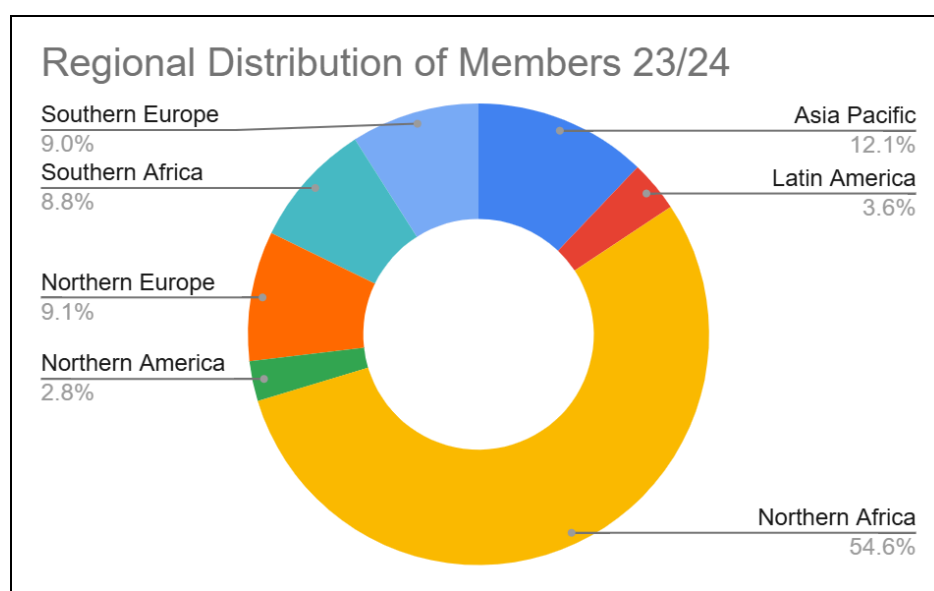
Projects can be conducted in various formats, including both online and in-person modalities. In 2022/2023, 23.1% of projects were carried out online (229 projects), while 76.9% were conducted physically (764 projects), totaling 993 projects. In 2023/2024, the online share slightly decreased to 22.1% (228 projects), while in-person projects rose to 77.9% (805 projects), out of a total of 1,033 projects. Overall, the data indicates a consistent distribution pattern across both years, with a slight decline in online initiatives and a

noticeable increase in physical engagements, suggesting a growing preference for in-person project implementation.

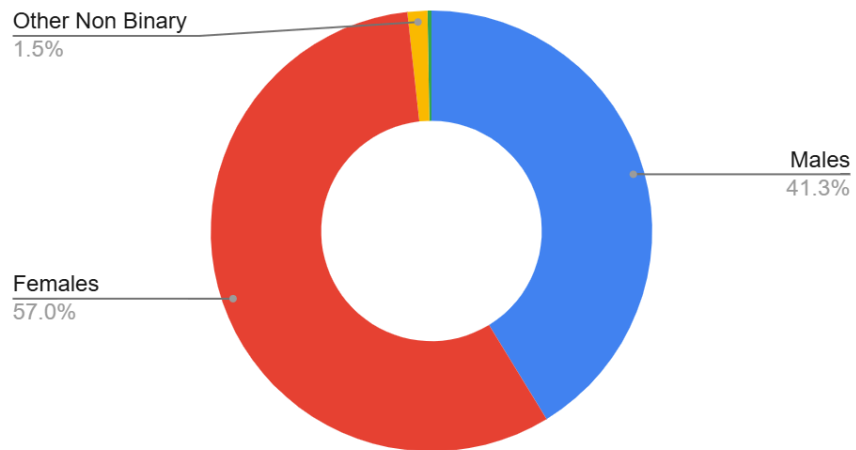
Based on project scale, in 2023/2024 there were 905 local projects (87.6%) and 133 international projects (12.9%). This represents a slight increase from the previous year, which recorded 850 local projects (85.2%) and 130 international projects (13.3%).

During the third round of data collection, additional information was gathered, including details on faculties and universities, available study programs, and the partnership status of each LC, including the potential for collaboration with IFSA alumni. While this information did not directly contribute to the statistical analysis, it served other strategic purposes, such as identifying opportunities and strengthening IFSA's partnerships at both local and regional levels. The data revealed that at least 40% of LCs that responded had already established local partnerships.

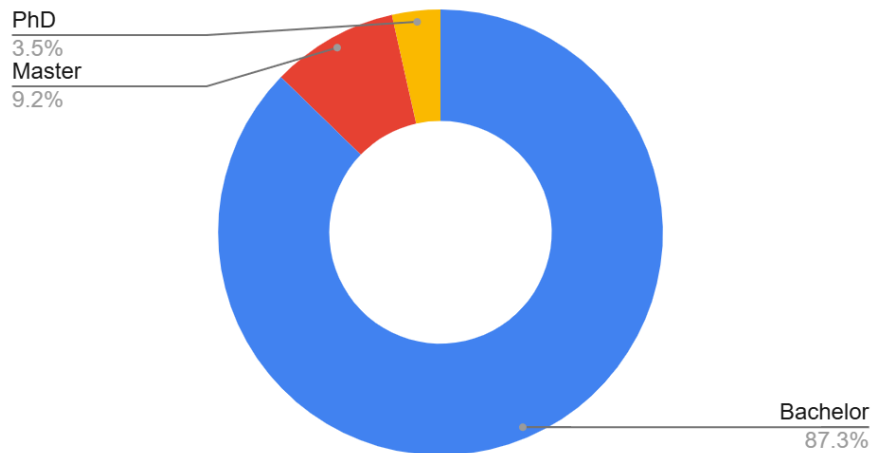

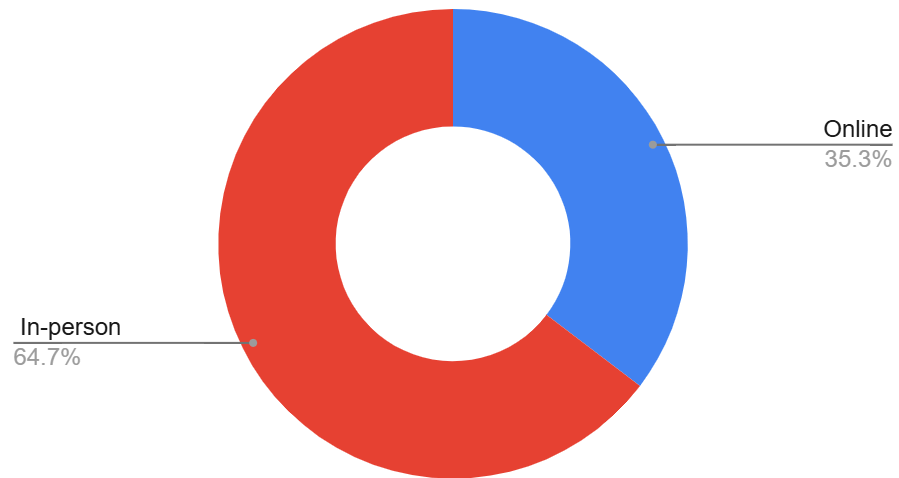
Gender Distribution in IFSA 2023/2024



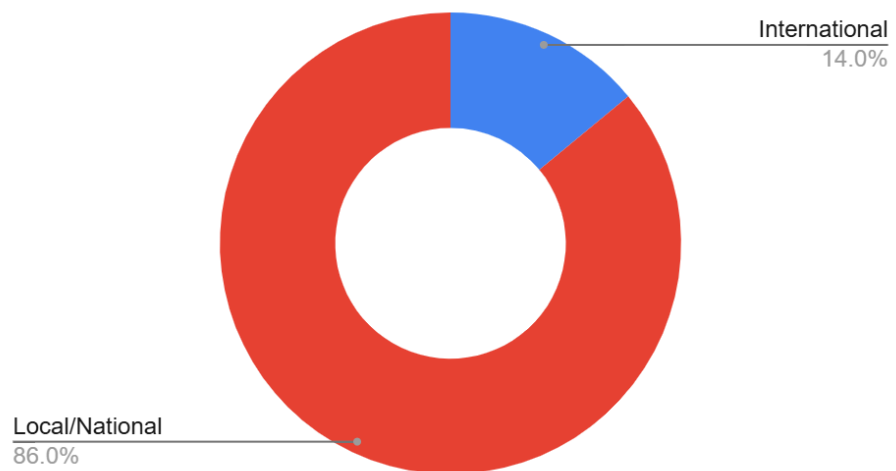
IFSA Members According to Study Level 23/24

New partnerships

FSC

The partnership with FSC was officially signed during the IUFRO World Congress 2024 in Sweden in the period from June 2024 to June 2029. The details of this collaboration, including matters such as IFSA's application for FSC membership and the dissemination of surveys, will be further discussed with the upcoming Board (2024/2025). Additionally, a new structure will be established within the IFSA Wheel, with the creation of the position of Head of the FSC Sub-Commission, who will serve as IFSA's focal point for FSC.

The collaboration between IFSA and the Mediterranean Youth Task Force (MYTF) aims to strengthen the partnership and expand IFSA's active involvement in the Youth Dialogue, which will be held during the 8th Mediterranean Forest Week in Barcelona, Spain, from 4 to 8 November 2024. The Youth Dialogue is being meticulously planned and coordinated by MYTF, in close collaboration with the Silva Mediterranea Secretariat and the Forest and Landscape Restoration Mechanism of the Food and Agriculture Organisation (FAO). Additionally, IFSA is preparing to take on a role as a co-organiser for the development of the Youth Roadmap on Forestry and will be presented during the World Food Forum Flagship Event 2024 in FAO Headquarters, Rome, Italy in October.

IUAF

A partnership has been established with IUAF to support the preparation of the World Agroforestry Congress (WAC) 2025, which will take place in Kigali, Rwanda. IFSA, in collaboration with IAAS and IUAF, is part of the Task Force. This initiative will be led by Clarissa Chimereze Enyi, with support from the IFSA President and the IFSA External Councilor. The primary responsibility of the Task Force is to foster synergies between the three organisations, while preparing and executing their respective roles in the WAC 2025, including pre-, during, and post-event engagement activities. These efforts will align with the congress's theme of "Agroforestry for People, Planet, and Profit," as well as with fundraising activities.

Spring Course

The IFSA Spring Course provides a week of two hours teaching from practitioners. The event has been successfully receiving 152 participants with an average attendance of 38.

Career Dinner

Career Dinner is a joint event between IFSA (International Forestry Students' Association) and IFSA-SAN (International Forestry Students' Association - Support Alumni Network). This event aims to close the divide between Forestry students and Alumni by creating a space for interaction through sharing experiences and expectations in the forestry career.

In the 2023/2024 term, we had 4 career dinner series with one every month from April to July. This was possible with the coordination between the Alumni and Coordination Team of IFSA SAN (Dan Burgar Kuzelicki and Silvia Abruscato) and the Internal Councilor of IFSA (Wening Ila Idzatilangi).

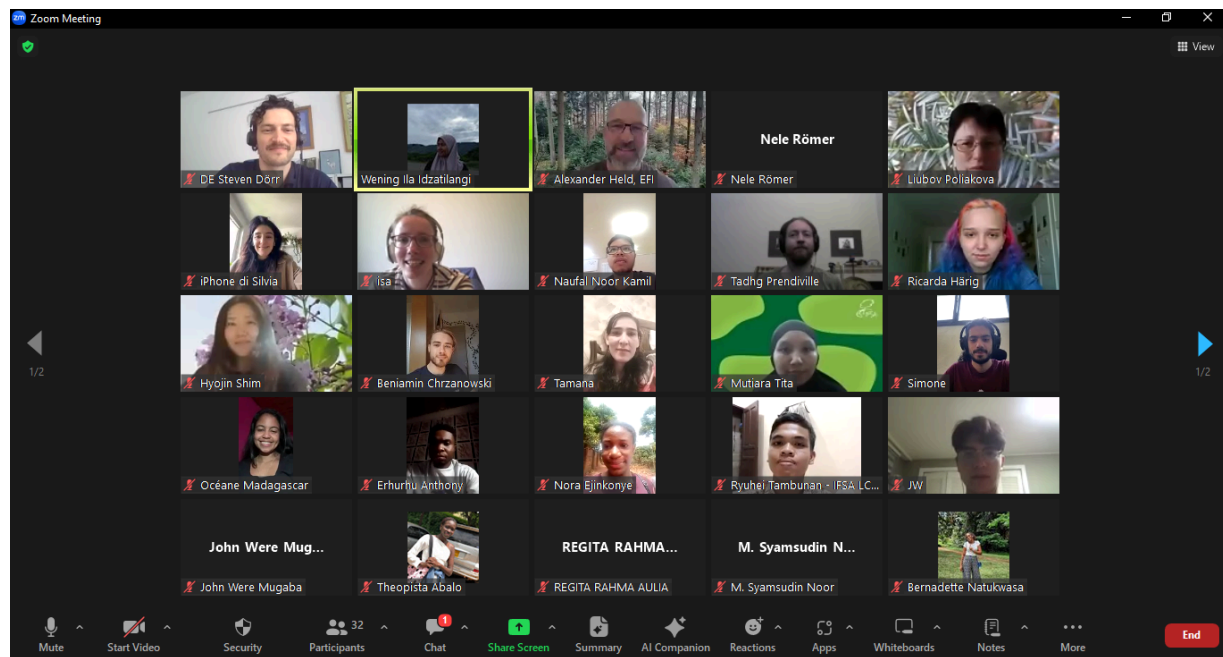

Recommendations

It is essential to begin preparations early to align with the best interests of IFSA members. This includes allowing time to send out a survey to gather discussion topics from members and coordinating with alumni to source speakers on the suggested themes.

Additionally, it is important to promote the events on IFSA's social media well in advance to ensure members are reminded and adequately prepared, which will help enhance participation and maximize the impact of each Career Dinner.

Effective communication and coordination among IFSA departments are crucial to prevent delays, such as issues with opening the Zoom Room.

IFSA-School Forest Project

The IFSA-School Forest Project is a pilot project in collaboration with the Forests for Tomorrow Foundation and the Gymnasium Carolinum Neustrelitz, led by IFSA members, Alexa Beaucamp and Isabelle Dela Paz. Through this, the TreE-Learning platform was integrated into the activities of secondary school students from Neustrelitz, Germany, and assessed its effectiveness as a supplementary learning resource.

Forty-six Grades 9 and 10 students from Neustrelitz, Germany participated in the pilot project by learning about Community Forestry in Asia through the TreE-Learning platform. Before and after completing the module, the students answered pre- and post-tests as a way for the Project team to compare their scores and assess the overall effectiveness of the platform on their learning.

The project results showed a significant improvement in the students' understanding and interest in the topic. However, improvements need to be made to the modules and overall platform to increase its effectiveness—this includes simplifying technical forestry terms and diversifying module topics and language options.

Beyond the technical aspects of project improvements, IFSA is committed to collaborating with our stakeholders for similar initiatives to achieve our common goal of enhancing forestry education and propagating knowledge for the younger generations. This could be through technical guidance or consultation, financial support, or other kinds of collaboration to enable us to upscale our initiatives and deepen our impact.

The project outcomes were presented by Dela Paz during her keynote presentation in the “Forests for the Future” Plenary session at the 26th IUFRO World Congress on 29 June 2024. More details about the project can be accessed [here](#).

- 3) Enable Students to Engage Globally

Each Goal is further defined by several **Sub-Goals** for which concrete activities are described in so-called **Action points**. To measure and monitor the implementation of the action points and to assess the impact, each action point is linked with at least one **Indicator** which is measured at the end of the term.

The term 2022/2023 marked the first term during which the numerous indicators stated in the IFSA Strategy were collected. To support the collection of indicators and ensure that all activities in IFSA work towards supporting the Strategy, a Strategy Work Plan was developed at the beginning of the term which linked all Commissions/Departments and their respective planned activities for the term to the specific Goals, Sub-Goals and Action points.
